² Legal ads are to be published in the Daily Hampshire Gazette at least five (5) business days prior to the date of the meeting per M.G.L. c. 131, §40. It is the Applicant's responsibility to ensure publication of the requisite legal ad/public notice by the legal ad publication deadline, and inquire to the commission regarding the completeness of their application prior to posting a legal ad. The legal ad schedule provided above is for convenience only, errors contained herein do not relieve the Applicant of responsibility for publishing the legal ad in a timely manner required by law.
